All undergraduate requirements for admission must be satisfied before enrolling in MBA required core or MBA elective courses. Students without an undergraduate degree in business may need to complete the following required foundation coursework or demonstrate proficiency in the following required foundation coursework* prior to taking courses for which there are prerequisites. **:

- Principles of Accounting I or Graduate Business Accounting Essentials
- Microeconomics or Graduate Business Microeconomics Essentials
- Financial Management or Graduate Business Finance Essentials
- Management Information Systems or Graduate Business Information Systems Essentials
- Business Analytics or Introduction to Behavioral Statistics or Graduate Business Statistics Essentials

Additional foundation coursework for Entrepreneurship & Corporate Innovation option:

Principles of Entrepreneurship

Students must earn a minimum grade of "C" in all of the above classes.

**Proficiency in these areas may be demonstrated through any of the following alternatives:

- A CLEP or DANTES exam if available. Credit will not be given for these courses with a passing grade on the exam, but a passing score will indicate proof of course knowledge.
- Applied knowledge of a given domain in the work environment. The
 extent to which relevant work experience demonstrates proficiency will
 be determined by the program director. Applicants who would like
 their work experience to be considered must submit a resume with
 their application.

Admission Requirements

In addition to the criteria established for general admission to graduate studies are the following departmental criteria:

Regular Admission

 GPA on a 4.0 scale (overall or in the last 60 hours of college credit) multiplied by 200 plus GMAT equal to at least 1000 AND GMAT score of at least 500,

OR

GPA of 3.0 on a 4.0 scale (overall or in the last 60 hours of college credit) with a Graduate Record Exam Score (GRE) of 147 for both Verbal Reasoning and Quantitative Reasoning and Analytical Writing of 3.5 or higher.

(When it is not possible to interpret academic eligibility by way of transcript, the graduate business program reserves the right to request further evidence of academic eligibility.)

Minimum grade of 'C' on all undergraduate foundation (prerequisite) courses.

Probationary Admission

All applicants must have the following:

 GPA on a 4.0 scale (overall or in the last 60 hours of college credit) multiplied by 200 plus GMAT score equal to at least 1000 AND GMAT score of at least 430,

OR

GPA of 3.0 on a 4.0 scale (overall or in the last 60 hours of college credit) with a Graduate Record Exam Score (GRE) of 144 for both Verbal Reasoning and Quantitative Reasoning and Analytical Writing of 3.5 or higher.

(When it is not possible to interpret academic eligibility by way of transcript, the graduate business program reserves the right to request further evidence of academic eligibility.)

- Minimum grade of 'C' on all undergraduate foundation (prerequisite) courses.
- Students admitted on probation must complete their first 9 hours of graduate course work with a grade "B" or better. Students not meeting this requirement are subject to dismissal from the program.

International students applying with a three-year degree must have their transcripts evaluated by an outside agency endorsed by AICE (www.aice-eval.org) or that is a member of NACES (www.naces.org).
