A. The bidder is hereby notified that Invitation for Bid 6010 is clarified as follows:

- 1. What will be the minimum/ maximum numbers of uniforms ordered during the contract period?**
 - a. There is no set number of uniforms that will be ordered. They are ordered as needed. Historically, we have ordered based on that year's class size. During the last contract period, we ordered 148 BDU Pants, 190 Embroidered Polos, and 100 Soft Shell Embroidered Jackets.

- 2. Who is the current vendor?**
 - a. The University currently contracts with Brown & Bigelow, Inc. and Guys Uniforms.

- 3. What is the design for the pants to be ordered?**
 - a. The pants orders will not require embroidery. They will be ordered blank.

- 4. The prior bid awarded was requested.**
 - a. Please see Attachment 1.

- 5. How many people are uniformed in the Law Enforcement Academy?**
 - a. Currently, there are 28. Average class size is between 22 and 28. There are two classes per year.
