- *Ark. Code § 12-19-102 requires the following establishments to post in restrooms and in a conspicuous place near the entrance of the establishment, or where posters and notices of this type customarily are posted, a poster described in subsection (b) of this section measuring at least eight and one-half inches by eleven inches (8½" x 11") in size:
- -A hotel, motel, or other establishment that has been cited as a public nuisance for prostitution under Ark. Code § 20-27-401
- -A strip club or other sexually oriented business
- -A private club that has a liquor permit for on-premises consumption and does not hold itself out to be a food service establishment
- -An airport
- -A train station that serves passengers
- -A bus stalion
- -A privately owned and operated facility that provides food, fuel, shower or other sanitary facilities, and overnight parking.
- -A nail salon or massage business licensed by the Department of Health.
