## Graduate Council Minutes

May 7, 2009

### Dean's Report:

- One project the Academic Standards Committee will be asked to look at in the future is continuous enrollment.
- Janzow will be taking a serious look at GSAC to determine if it should continue.
- The Office of the Vice Provost and School of Graduate Studies had to deal with budget cuts of 2% for instructional units and 3% for non-instructional units. In doing so, the graduate student professional development fund and graduate faculty mini-grant fund were closed but a small amount of funds may be available for these types of requests through operations.

### Academic Standards Committee Report (Taylor):

- Taylor submitted a document of his committee's recommendations resulting from the review of all academic standards and policies of the School of Graduate Studies. These changes were approved, as amended. (Chamberlain/Judd)

### Assessment Committee Report (Judd):

Department Chairpersons were interviewed to find out what each program does and 1-10 randomly selected samples from each were reviewed by Judd's committee. On a positive note, all programs were satisfactory but the committee noted the following:

- 1) critical thinking component was weak
- 2) use of web pages and non-peer reviewed sources were prevalent
- 3) one act of plagiarism was found
- 4) departments should think more how students' projects fit into the programs
- 5) variation in formatting should be addressed
- 6) departments should define some type of scoring ruberick for projects
- 7) all departments should archive all projects

### Curriculum Committee Report (Branscum):

- Branscum's committee approved the items on the agenda.

- Continuous Enrollment is being deferred to the Academic Standards Committee.
- Members were asked to talk to their departments regarding the proposed requirement that all capstone projects be submitted to the School of Graduate Studies for discussion at a future meeting.
