## **CURRICULUM OF COURSES TAUGHT:**

### **Introduction to Law Enforcement**

- Instructional mode was face-to-face
- The learning objectives are to present an overview of the field of law enforcement, including the complexities within it. This course also explores the evolution of policing, organization and function, and the challenges to the profession.

### **Introduction to Corrections**

- I have taught this course in a face-to-face setting and via ITV with a blended format as well as online.
- The purpose of this course is to provide an in-depth look at the past, present and future of corrections as well as identify the many subcomponents of modern-day corrections. This course also focuses on the many issues which face the correctional enterprise today and examines the opportunities represented by new and developing technologies.

### **Correctional Institutions**

- I have taught this course in a face-to-face setting and via ITV with a blended format as well as online.
- The goal of this course is to explore the ideology behind the creation and history of prisons as well as the challenges, features and legal holdings involved in their maintenance. This course also focuses on release from prison and the topics of reintegration and community corrections.

### **Community Based Corrections**

- I have taught this course in a face-to-face setting and via ITV with a blended format as well as online.
- The course objective is to provide students with comprehensive, evidence-based practices and research for community based alternatives and correctional programs. Further, to illustrate an emphasis on both treatment orientation and community partnerships as a major component in the success of community based corrections.

### **Juvenile Justice**

- I have taught this course in a face-to-face setting and via ITV with a blended format
- The learning objectives are to familiarize students with the history and extent of juvenile delinquency and to explore the theories and issues related to the process of dealing with juvenile delinquents.

### **Offender Rehabilitation**

- I have taught this course in a face-to-face setting and via ITV with a blended format as well as online.
- The purpose of this course is to explore the historical foundations and approaches to correctional counseling as well as the strategies utilized to reduce offender recidivism. This course also focuses on special types of offenders, classification, and the importance of case management.

### **Victimology**

- I have taught this course in a face-to-face, blended setting
- The purpose of this course is to study the victim's role in the criminal event; the process of victimization; patterns, trends, theories; and victim-offender relationships.

### **Field Experience in Correctional Institutions**

- This course features practical application with the instructor and students meeting face-to-face on a daily basis for several weeks outside of the classroom setting
- The purpose of this course is to introduce the student to the prison environment by visiting several different institutions. Through each visit, students are exposed to the different models of prisons and jails--maximum, medium, minimum, juvenile, and gain an understanding of the inner-workings of correctional facilities.
