The main objective of the course was to familiarize students with the conceptualization, structure and operations of juvenile justice with regard to the criminal justice system.

Presentations included research conducted on the 32nd Judicial Circuit of Missouri Juvenile Division, presented at the Academy of Criminal Justice Sciences in March 2014 in Philadelphia as well as research conducted on offenders' perceptions of probation, presented at the Regional Administrator meeting for the Missouri Board of Probation and Parole in Jefferson City, Missouri in December 2014, in March 2015 at the Academy of Criminal Justice Sciences in Orlando, and in April 2015 at Southeast Missouri State University's Provost's Faculty & Research Creativity Showcase. My duties also included advising current and prospective students, attending recruiting events and aiding in the development and organization of Criminal Justice day at Southeast.

Court Service Officer, 2016 – 2017

Johnson County Court Services, Johnson County, KS

- My duties included coordinating the Juvenile Drug Court in Johnson County, KS. This included supervising roughly 50 juveniles placed on Diversion in Johnson County, KS who were screened for Drug Court. In the program, I worked closely with the juveniles, their parents, the Honorable Judge Thomas Foster, treatment providers, and various other agencies in the community. The program was designed around the National Drug Court Institute's Judicial Benchbook model. A heavy emphasis was placed on evidence-based practices, graduated sanctions, and cognitive behavioral therapy.

Youth Care Advisor, 2015 – 2016

Johnson County Juvenile Detention Center, Johnson County, KS

- My duties included supervising juvenile residents and ensuring the security and safety of the juvenile detention center. This included daily interaction with residents, daily supervision of residents during free time, gym time, and dining. This also included transporting residents to and from work, court, and other programming if necessary. This also included responding to physical or emergency situations related to health and using the proper force or verbal commands to deescalate the situation.

- My duties included overseeing a caseload of 40 to 110 offenders, preparing and presenting a Financial Management class through Private Correctional Services for offenders, writing violation reports, and communicating with the Courts and Judges. Furthermore, I communicated with various organizations in the community, including community service sites, SATOP services, and inpatient and outpatient treatment centers. My duties also included covering weekly Court dockets and handling the offender intake process, utilizing alcohol monitoring and location monitoring devices, and supervising drug court.

- My duties during the 240-hour internship included observing meetings between offenders and officers, composing non-compliance reports to the Court, communicating with offenders regarding technical non-compliance, observing presentence investigation interviews, and helping officers compile the appropriate information needed for presentence investigations. I also observed Court hearings, attended Veteran's Court, composed and sent VCCA change of residence notifications to state and local law enforcement agencies, wrote various other reports for officers, and interacted with other federal agencies, including the U.S. Attorney's Office and the U.S. Marshals Service. Furthermore, I attended meetings with state probation and parole officials regarding offender re-entry.

Introduction to Criminal Justice (Online, Face-to-Face, ITV)

- General survey of federal, state, and local agencies involved in the administration of justice including police, courts, and corrections.

Introduction to Law Enforcement (Online, Face-to-Face, ITV)

- Philosophy, history and problems of law enforcement; organization and jurisdiction of local, state and federal law enforcement agencies will be examined.

Introduction to Criminal Courts (Online, Face-to-Face, ITV)

- Organization and structure of state and federal criminal courts. Responsibilities of courtroom actors and their decisions will be addressed.

Introduction to Corrections (Online, Face-to-Face, ITV)

- Introduces students to problems and the diversity of emphasis being placed on correctional programs.

Community Based Corrections (Online)

- Study of group homes, work release programs, half-way houses, work-study projects and other community based programs.

Juvenile Justice (Online, Face-to-Face)

- Designed to acquaint students with the problems of dealing with juveniles in the criminal justice system.

Offender Rehabilitation (Face-to-Face, ITV)

- Analysis and evaluation of current theories and methods of treatment and classification in the correctional environment.

Crime and Human Behavior (Online, Face-to-Face)

- An interdisciplinary study of the causes and effects of crime and delinquency.

Drugs and Behavior (Online, Face-to-Face)

- An interdisciplinary coverage of psychoactive drugs from the perspectives of psychopharmacology, history, and criminal justice.

Domestic and International Terrorism (Online)

- This course surveys perspectives pertaining to the etiology of terrorism at both the domestic and international level. Study of the various tactics used by identified terrorist groups is explored. In addition, the techniques of counter terrorism are assessed.

Criminal Procedure (Online)

- Survey of the legal aspects of criminal procedure from arrest through appeal. Focuses on the law of arrest, search and seizure and the nature of legal proof at criminal trial.
